NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Thursday, November 13, 2025, at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

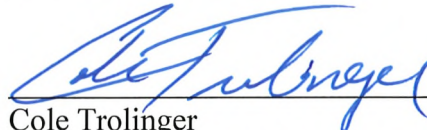
1. Public comments;
2. Review and approval of minutes of the October 9, 2025, Board of Directors meeting;
3. Status of audit report for fiscal year ended September 30, 2025;
4. Status of continuing disclosure report (due March 31, 2026);
5. Bookkeeper's Report, including review of financial and investment reports, authorizing the payment of invoices presented;
6. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
7. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and moving of accounts to uncollectible roll;
8. Report of and legal action taken by the District's delinquent tax collection attorney, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claims;
9. Operations Report, including:
 - a. Monthly Report;
 - b. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - c. Any appeals of District charges;
 - d. Authorization of the repair and maintenance of District facilities;
 - e. Report on District's water accountability;
 - f. Proposals for additional security measures at the District's Water Plant;
 - g. Consider approval of Amendment to Professional Service Agreement by and between the District and Municipal Operations and Consulting, Inc.; and
 - h. Authorize operator and engineer to perform 2026 water loss audit;

10. Engineer's Report, including:
 - a. Authorizing the design and/or advertisement for bids and/or award of construction contracts, and authorize acceptance of Texas Ethics Commission ("TEC") Form 1295, for the construction of facilities within the District, and approving of related storm water plans, including:
 - i. Proposed power line rerouting at the District's Water Plant and Chloramine Conversion;
 - ii. Proposed redesign of District stormwater quality features; and
 - iii. Surface Water Line Connection;
 - b. Status of construction of facilities to serve land within the District, including the approval of any change orders, including:
 - i. Water Distribution System Rehabilitation/Replacement; and
 - ii. Proposed replacement of existing fence at the District's Water Plant;
 - c. Acceptance of site and/or easement and/or utility conveyances for facilities constructed or to be constructed for the District for operation and maintenance purposes;
 - d. Status of Storm Water Quality Permits; and
 - e. Requests for Utility Commitment Letters;
11. Report on the District's generator, including discussion regarding possible change of District's Qualified Scheduling Entity; authorize any action necessary in connection therewith;
12. Developer's Report;
13. Authorize attorney to file Eminent Domain Report with the Texas Comptroller of Public Accounts prior to February 1, 2026, pursuant to § 2206.154, Texas Government Code;
14. Authorize preparation and filing of initial Local Government Bond, Tax, and Project report pursuant to chapter 403, Texas Gov't Code, as amended by H.B. 103;
15. Matters related to the Directors Election to be called for May 2, 2026, including authorization to post Notice Regarding Candidate Filing Period;
16. Attorney's Report;
17. Convene in Closed Session pursuant to Open Meetings Act, Section 551.074, 551.072 and/or Section 551.071, Texas Government Code;
18. Reconvene in Open Session and authorize any action resulting from matters discussed in Closed Session; and

20. Matters for possible placement on future agendas.
